As per the existing instructions, Annexure 'G' and 'K' of the Passport Application form / Information booklet are required to be sworn before Judicial Magistrate and First Class Judicial Magistrate. However, it has been brought to the notice by various passport applicants that they find it difficult to submit these Annexures sworn before Judicial Magistrates. Ministry has been also receiving references from various PIAs for relaxation in this matter and authorizing certain other authorities before whom these Annexures can be sworn.

- 2. Keeping in view the difficulties faced by the passport applicants, the matter has been examined in consultation with L & T Division of the Ministry. It has been decided that Annexure 'G' and 'K' may be accepted even if sworn before 'Executive Magistrate'. Amended format of these Annexures are attached.
- 4. The above may kindly be brought to the notice of all concerned for information and compliance.
